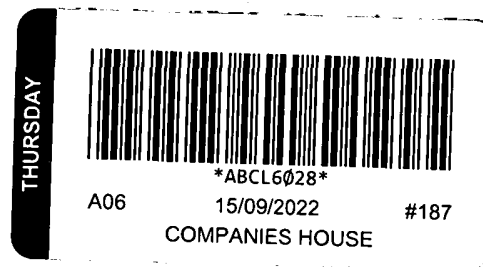

**GOING CONCERN**

The Company has adequate financial resources and as a consequence, the Directors believe that the Company is well placed to manage its business risks successfully and to meet its liabilities as they fall due for at least twelve months from the date of approval of these financial statements. The Directors have considered the impact of ongoing COVID-19 and other geo-political uncertainties and their potential implications on the Company's future operations. Whilst there are significant wider market uncertainties which may impact its subsidiaries' portfolio company investments and fund investors, the Directors do not believe this will impact the ability of the Company to continue as a going concern over the next 12 months. For this reason, the Directors have adopted the going concern basis in preparing these financial statements.

**Opinion**

We have audited the financial statements of Touchstone Innovations Limited (the 'company') for the year ended 31 December 2021 which comprise the statement of comprehensive income, the balance sheet, the statement of changes in equity and notes to the financial statements, including significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including FRS 101 'Reduced Disclosure Framework'.

In our opinion the financial statements:

- give a true and fair view of the state of the company's affairs as at 31 December 2021 and of its loss for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

**Basis for opinion**

Notes to the Financial Statements  
for the Year Ended 31 December 2021

1. STATUTORY INFORMATION

Touchstone Innovations Limited is a private company, limited by shares, registered in England and Wales. The Company's registered number and registered office address can be found on the Company Information page.

The principal activity of the Company in the period under review was that of acting as a holding company for a technology transfer business and an investment holding vehicle with investments in both start up and more established technology companies.

2. ACCOUNTING POLICIES

**Basis of preparation**

The Financial Statements of Touchstone Innovations Limited (the "Company") are for the year ended 31 December 2021. The principal accounting policies adopted in the preparation of the financial statements are set out below. The policies have been consistently applied to all the years presented, unless otherwise stated. These financial statements have been prepared in accordance with Financial Reporting Standard 101 Reduced Disclosure Framework ("FRS 101").

In these financial statements, the Company has applied the exemptions available under FRS 101 in respect of the following disclosures: a Cash Flow Statement and related notes; disclosures in respect of transactions with wholly owned subsidiaries; disclosures in respect of capital management; the effects of new but not yet effective IFRSs; and disclosures of transactions with a management entity that provides key management personnel services to the Company. The Company has also applied the exemption from the requirements of IFRS 7 Financial Instruments: Disclosures, the equivalent disclosures are included in the IP Group plc consolidated financial statements.

**Changes in accounting policies**

**(i) New standards, interpretations and amendments effective from 1 January 2021**

There are no amendments to accounting standards, or IFRIC interpretations that are effective for the year ended 31 December 2021 that have had a material impact on the Company's financial statements.

**(ii) New standards, interpretations and amendments not yet effective**

No new standards, interpretations and amendments not yet effective are expected to have a material effect on the Company's future financial statements.

**Going concern**

The Company has adequate financial resources and as a consequence, the Directors believe that the Company is well placed to manage its business risks successfully and to meet its liabilities as they fall due for at least twelve months from the date of approval of these financial statements. The Directors have considered the impact of the spread of COVID-19 and other geopolitical uncertainties and their potential implications on the Company's future operations. Whilst there are significant wider market uncertainties which may impact its subsidiaries' portfolio company investments and fund investors, the Directors do not believe this will impact the ability of the Company to continue as a going concern over the next 12 months. For this reason, the Directors have adopted the going concern basis in preparing these financial statements.

**Taxation**

The charge for taxation is based on the profit for the year and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes.

**Related party transactions**

In accordance with IAS 24 "Related Parties Disclosures", the Company discloses details of material transactions between the reporting entity and related parties. However, transactions between the Company and other Group companies have not been disclosed in accordance with the exemption in IAS 24 paragraph.

**Preparation of consolidated financial statements**

The financial statements contain information about Touchstone Innovations Limited as an individual Company and do not contain consolidated information as a parent of a group. The Company is exempt by virtue of section 400 of the Companies Act 2006 from the requirement to prepare group accounts on the basis that the parent company is included in the accounts of a larger group as identified in note 13 of these financial statements.

3. EMPLOYEES AND DIRECTORS

During the year the Company had no employees (2020: none). The directors were remunerated for their services to other group companies within the group headed by the Company's ultimate parent, IP Group plc. The directors of the Company chose to waive any remuneration during the year ended 31 December 2021, for their services to this entity.
